

MINUTES OF THE HIGHWAY COMMISSION MEETING
December 6, 2017

The Williamson County Highway Commission met on Wednesday, December 6, 2017 at 8:30 a.m. at the Williamson County Highway Department facility at 302 Beasley Drive in Franklin, TN. Commission members present: County Mayor and Highway Commission Chairman, Rogers Anderson; Commissioners Charles Wilson, Stan Tyson, Wayne Davis, and Charlie Bennett.

Also present were: Eddie Hood, Highway Superintendent; Greg Boll, Elaine Vasquez, Randy Hickman, Brandon Wright, Highway Department; Joe Horne, Community Development Director; Floyd Heflin, William Andrews, Engineering; Nena Graham, Budget Director; Robert Cook, County Attorney, Buerger, Moseley, and Carson, and other interested individuals.

Chair Anderson called the meeting to order at approximately 8:30 a.m. and called for the approval of the minutes of the November 1, 2017 meeting. Commissioner Wilson moved for approval, seconded by Commissioner Tyson. The motion passed unanimously, 5-0.

Special Announcements: There were no Special Announcements.

Citizen Communications: **Monique Kueker**, 4245 Warren Road, Franklin, TN, appeared before the Commission to express her concerns for safety regarding increased traffic on County roads as a result of the Colletta Park development. She also expressed concerns that the City of Franklin has plans to open Beacon Hill Drive and Stanford Drive to through traffic into Colletta Park Subdivision. Ms. Kueker presented a letter to the Highway Commission which is attached.

Susan Kaplan, Beacon Hill Drive, Franklin, TN, stated that she also has concerns that the City of Franklin has plans to open Beacon Hill Drive and Stanford Drive to through traffic into Colletta Park Subdivision. She also expressed her concerns for safety, stating that many children live in the Franklin East and Cross Creek neighborhoods. She asked the Highway Commission for any help they can give to prevent this from happening.

Superintendent Hood stated that he hasn't been approached by the City of Franklin with any changes that would open Beacon Hill Drive or Stanford Drive to through traffic into the Colletta Park development.

Commissioner Tyson stated that the Highway Commission has already taken action regarding Beacon Hill Drive and Stanford Drive. The Commission voted unanimously that the stubs on Beacon Hill Drive and Stanford Drive will remain emergency access points into Colletta Park Subdivision.

Superintendent Hood stated that he and Mr. Chad Collier reviewed the Vineyard Valley Subdivision plans for improvements to Eudaily-Covington Road. He stated that he and Staff recommend approval.

Commissioner Bennett moved for approval of the Vineyard Valley Subdivision off site road improvement plan. It was seconded by Commissioner Tyson and passed unanimously, 5-0.
