The Williamson County Highway Commission met on Wednesday, October 6, 2021 at 8:30 a.m. at the Williamson County Highway Department facility at 302 Beasley Drive in Franklin, TN. Commission members present: County Mayor and Highway Commission Chairman, Rogers Anderson, Wayne Davis, David Coleman, and Stan Tyson. Commissioner Charles Wilson was unable to attend.

3. **REPORT FOR ACCEPTANCE OF CRIMSON LEAF LANE, AND EDMORE DRIVE, FALLS GROVE SUBDIVISION, SECTION THREE, AS A PART OF THE WILLIAMSON COUNTY ROAD SYSTEM. (HC Coleman; CC District 5, Little/Lothers).**

Superintendent Hood and Staff recommended acceptance with exception to an issue with the sidewalks at the intersection of Edgemore Drive and Pleasant Gate Lane and at the intersection of Pleasant Gate Drive and Wellsford Lane. Superintendent Hood stated that 391 feet of sidewalk at those locations are within the County right-of-way due to a gas line that can't be disturbed. Superintendent Hood stated that the Home Owners Association will be responsible for the maintenance of the sidewalks. It was suggested to amend the Report for Acceptance and remove the paragraph regarding sidewalks and handicap ramps. The changes will be reflected in the forthcoming Resolution.

Commissioner Coleman moved for acceptance of the Report for Acceptance as amended. It was seconded by Commissioner Tyson and passed unanimously, 4-0.
