

**MINUTES OF THE HIGHWAY COMMISSION MEETING**

**July 6, 2022**

The Williamson County Highway Commission met on Wednesday, July 6, 2022 at 8:30 a.m. at the Williamson County Highway Department facility at 302 Beasley Drive in Franklin, TN. Commission members present: County Mayor and Highway Commission Chairman Rogers Anderson, Stan Tyson, Wayne Davis, and David Coleman. Charles Wilson was unable to attend.

Also present were: Greg Boll, Elaine Vasquez, Randy Hickman, Highway Department; Nena Graham, Budget Director; Phoebe Reilly, Assistant Budget Director; Robert Cook, County Attorney, Buerger, Moseley, and Carson, and other interested individuals.

Chairman Anderson called the meeting to order at approximately 8:30 a.m. and called for the approval of the minutes of the June 1, 2022 meeting. Commissioner Tyson moved for approval of the minutes, seconded by Commissioner Davis. The June 1, 2022 Highway Commission meeting minutes were approved unanimously, 4-0.

**NEW BUSINESS:**

1. **Resolution 7-22-6 RESOLUTION AMENDING THE 2022-23 CAPITAL PROJECTS BUDGET AND APPROPRIATING UP TO \$3,700,000 FOR MAJOR CORRIDOR STUDY PROJECTS AND THE PURCHASE OF NEW EQUIPMENT – REVENUES TO COME FROM UNAPPROPRIATED HIGHWAY FUND BALANCE.**

Ms. Graham stated that the 2022/23 Capital Projects were approved at the Budget Review. She added that this Resolution makes it final and puts it on the books so the money can be moved.

Commissioner Coleman moved for approval of Resolution 7-22-6. It was seconded by Commissioner Davis and passed unanimously, 4-0.
